
Programme **Context**

- October 2019: Closure of two peat fired power stations (Offaly & Longford)
- Decarbonisation strategy accelerated further to 2023
- Midlands Regional Transition Team (MRTT) established working across four areas:
 - Securing special status
 - Addressing the needs of employees
 - Emerging opportunities from property land portfolios
 - Marketing the Region

















Programme Context

Two Stage process:

Stage 1 - Midlands Engagement Process

To inform National Just Transition Fund Criteria

Stage 2: Just Transition Fund

- Just Transition Fund 2020 dedicated fund of €11m, financed by Government through an allocation of €6m from an increase in the carbon tax and an additional €5 million committed by ESB (56 projects – €22.1m)
- Priority 1: Employment and Enterprise Supports
- Priority 2: Training Supports
- Priority 3: Community Transitioning Supports

The climate challenge

Global carbon emissions mean that the world is heading to more than 2°C of warming. This would have severe consequences, not only for the environment, but also for our societies and economies.

To respond to this there is a pressing need for countries to decarbonise their economies. In doing so, energy generation is key.


In Ireland, the government has taken a decisive step to cease the industrial harvesting and burning of peat and to invest significantly in renewables.

This both removes the carbon emissions from peat burning but also allows the remediation of bogs, which are a major carbon sink.















How has this challenge been captured in policy?

The European Green Deal and the European Just Transition Mechanism recognise that regions and communities across the EU require support to transition to climate neutrality by 2050.

> The EU Just Transition Mechanism will receive €55 billion in funding between 2021 and 2027. Of this, Ireland will receive €84.5 million, which will be further supplemented by match funding from the Irish Government.


> > To move towards climate neutrality by 2050, the Climate Action and Low Carbon Development (Amendment) Act 2021 commits the Irish Government to reduce Ireland's greenhouse gas emissions by 51% (from 2018 levels) by 2030.













The consequences of moving to a climate neutral economy for Ireland


- The cessation of industrial peat cutting
- Closure of ESB and BnM facilities in the wider Midlands region
- Loss of employment opportunities in the area
- Social and economic impacts

The cessation of peat cutting has had a significant impact on communities across the wider Midlands region.


To make the transition to a climate neutral economy fair for everyone, we must support those counties and communities most impacted.


















New modes of tourism - active, environmental and heritage

Peatland Biodiversity Boardwalk at Lullymore Heritage & Discovery Park

The Lullymore Heritage and Discovery Park is a key visitor attraction within the region which welcomes over 50,000 visitors each year. It has recently received additional funding through the Just Transition Fund to extend it's peatland biodiversity boardwalk by 300 metres. Additional information signage will educate visitors on the Bog of Allen and its capacity to store carbon.

Lesson Learned

- Exemplifies the potential of the peatlands as a site for tourism and leisure.
- Upgrading existing attractions to increase their offer and develop their potential as tourism destinations.
- This will support additional seasonal and full-time employment.
- This will support surrounding communities, who can capitalise on the benefits of tourism growth and the rewilding of the peatlands.

Sectoral innovation and SME incubation – agriculture, food, manufacturing

Ferbane Food Campus and Innovation Centre

Ferbane Business & Technology Park was established in 2003 to create a business cluster which could boost employment. After ESB vacated the top floor of the office building, feasibility studies explored opportunities within the food sector.

The original industrial unit was sold, and new industrial units were bought and divided into 3 Food Incubation Units. All offices are now at full capacity, and 70 people are currently employed here. The park has enabled 40 people to set up their own businesses and has provided training to over 300 people.

Lessons Learned

- The project created employment opportunities for local people after 1200 local jobs were lost due to the cessation of peat production.
- The creation of area specialism and innovation has helped to attract new businesses and support start ups. The proposed expansion of the site will enable further sectoral innovation and job creation.
- Local people have been inspired to set up in the industry or upskill by engaging in training.


















Green skills - retrofit, energy, modern methods of construction

Home Upgrades in North Tipperary


Funding has been secured to promote capacity building, auditing and retrofitting of the local housing stock in communities around Littleton, which was affected by the closure of Littleton's peat factory.

The first phase involves raising community awareness and engaging local people in the process, building a partnership between local people and their local community development associations. The second phase will involve the retrofitting of over 40 homes locally over 2.5 years. During this time, the project will support 25 jobs through energy upgrade works.

Lessons Learned

- Engaging the local community in the energy transition upskills residents and prompts community-led energy retrofitting.
- Efficiency of homes are increased, reducing costs for owners and tenants.
- Increases knowledge of sustainability and methods of self-help amongst communities.

For this project, Energy Communities Tipperary Cooperative CLG (which represents 14 community energy teams) was the recipient of National Just Transition funding.

Saint Joseph's Community Centre: Remote Working Hub and Cycle Tourism Centre

Kilcormac Development Association received funding for the development of a tourism recreation hub and community remote working hub within Saint Joseph's Community Centre. The tourism recreation hub would not only create new jobs, through facilities such as bicycle hire, a coffee shop and a tourist office, but would also begin to unlock Kilcormac's potential as a gateway to Boora. In addition, the Remote Working Hub will offer co-working facilities for commuters and businesses, such as office hubs and meeting rooms.

Lessons Learned

- The project will enable the community centre to generate income which can be reinvested in community projects.
- The creation of additional tourist facilities has the potential to strengthen the tourism sector locally and stimulate Kilcormac's economy, using its proximity to Boora.
- · Remote working job opportunities are created for local people.

Kilcormac Development Association was the recipient of National Just Transition funding for this project.

















Ballycommon Training Workshop

Ballycommon Telework & Training Centre is a community owned Rural Social Enterprise which delivers IT and safety training. Just Transition funding was used construct a workshop and to design and deliver new training.

The aim of this project is to upskill and retrain local people who have been laid off as a result of the phasing out of peat extraction, so that they may be competitive within the job market. The area faces skills shortages in retrofit for homes, renewable energy assets, solar energy and robotics, which has shaped the themes of the training.

National Just Transition funding accounted for 85% of the total cost of this project. The grantee was Ballycommon Telework and Training Centre CLG, a community owned business.



- The local skills gap was identified and addressed through the targeting of specific courses offered.
- The provision of this facility has enabled the upskilling and reskilling of residents affected by the phasing out of peat extraction.
- There is a clear focus on skills relating to retrofitting and solar energy, which will become increasingly relevant and make the community resilient in the future.














Format:


- Face-to-Face events in 21 communities

Format:


- Communities will have ongoing support from Urban Foresight & The Wheel throughout this period for advice, guidance and signposting
